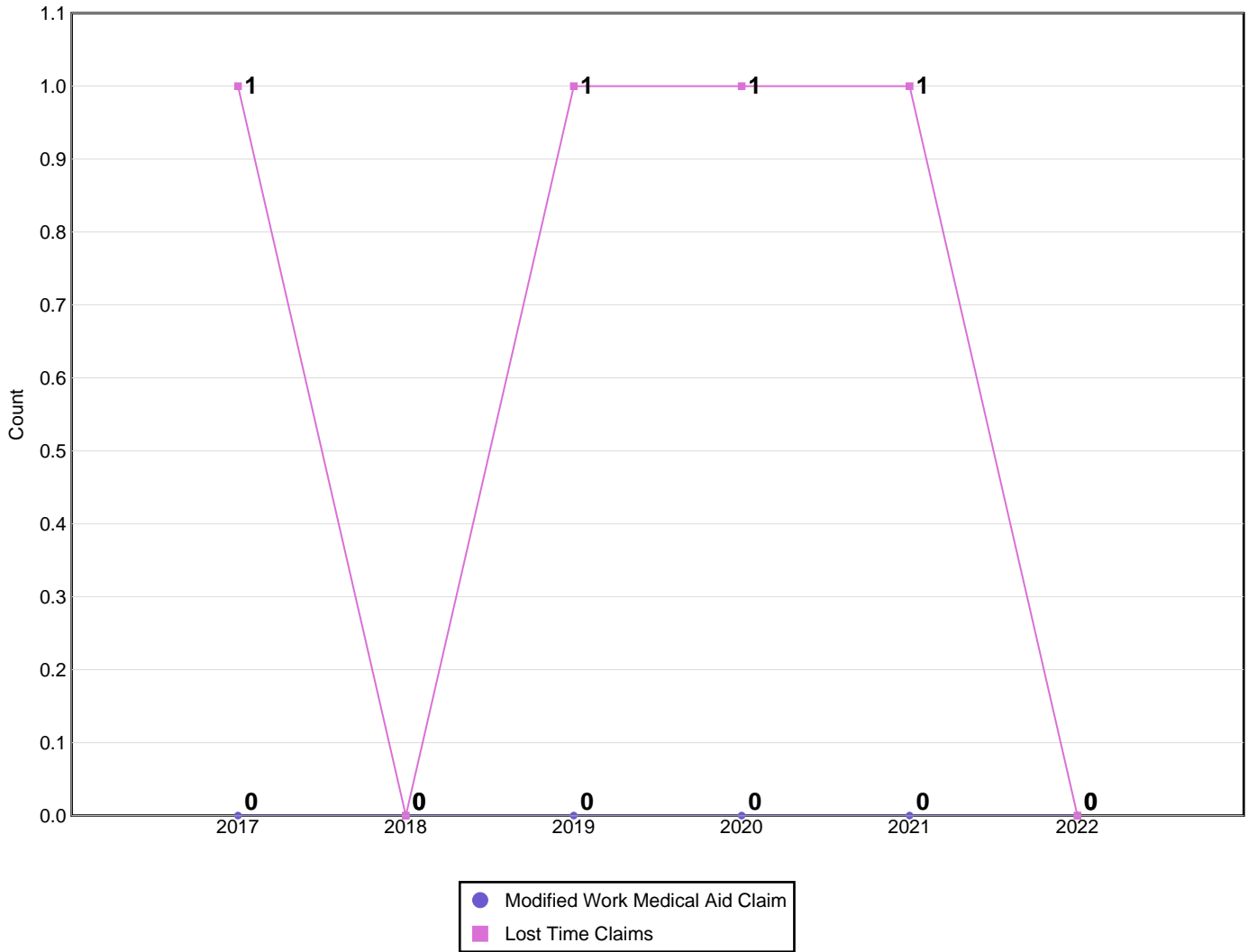

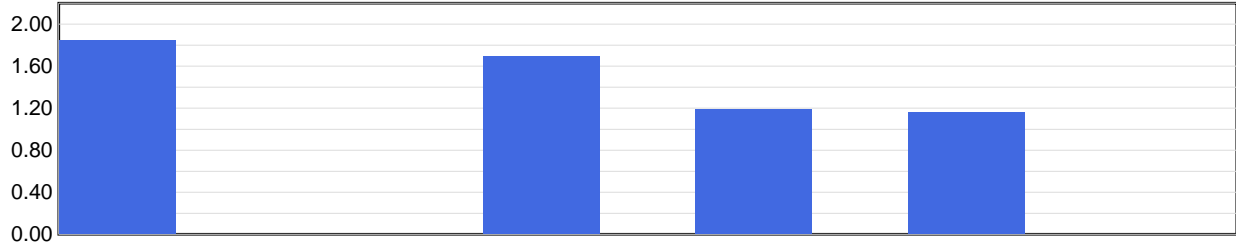

(Lost Time Claims per 100 Workers)



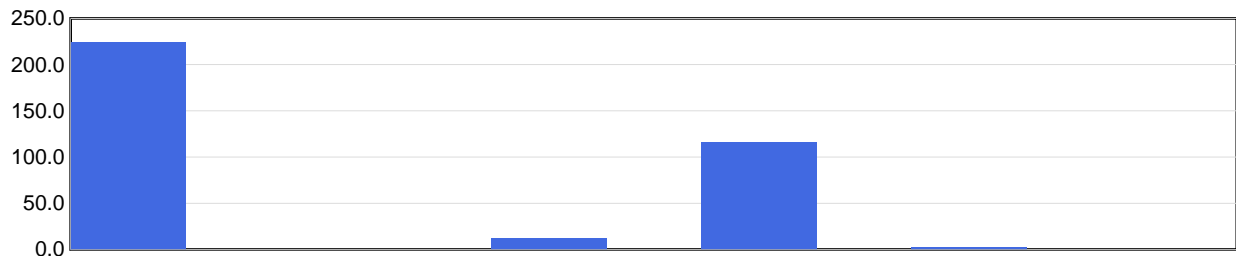

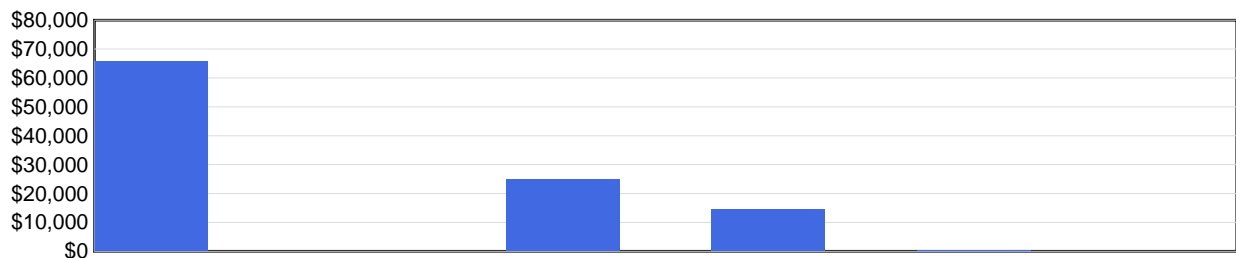

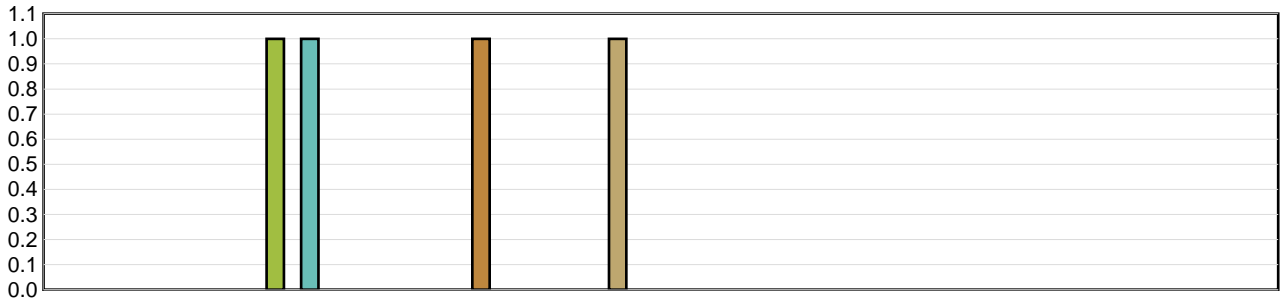

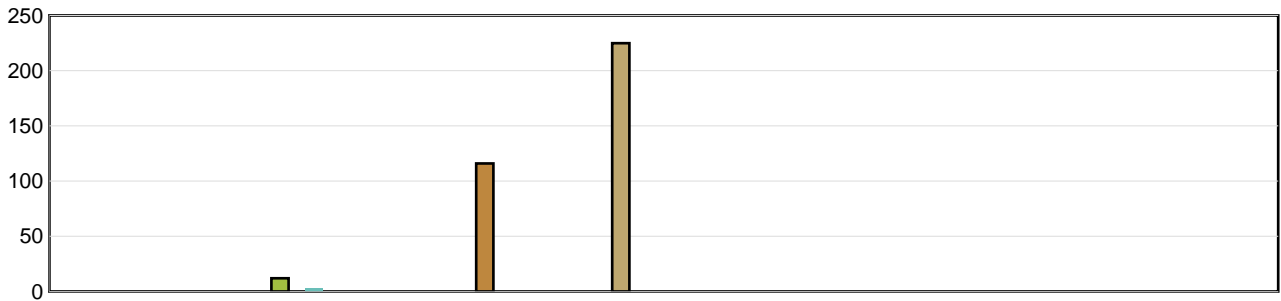
Injured Worker's Age - for Years: 2017 to 2022
